

## Kalgoorlie-Boulder Airport

### Schedule of Fees and Charges 2020-2021

From 1 July 2020 to 31 December 2021 – adjusted to include a nominal increase as determined by the City of Kalgoorlie-Boulder Council on 28 April 2020.

#### Terminal Services Levy

Levy on all arriving and departing passengers (\*including charter passengers), with the exception of same-day through Regular Passenger Transport (RPT) services, who arrive at and/or depart from the Kalgoorlie-Boulder Airport terminal.

\*The following resolution in relation to the payment of Terminal Services Levies (TSL) by charter passengers was carried by an absolute majority at the 10 June 2013 meeting of the City of Kalgoorlie-Boulder Council:

That Council:

1. As from 1 January 2014 authorise the imposition of TSL against the passengers of charter aircraft who use the Kalgoorlie-Boulder Airport's terminal facilities and whose primary port of arrival to or departure from Kalgoorlie-Boulder is the Kalgoorlie-Boulder Airport terminal.
2. Agree that where charter operators do not provide the necessary passenger carriage statistical reports, the TSL be imposed in relation to a deemed 100% passenger loading of the aircraft concerned.
3. Agree that 50% of the standard TSL charge should apply to same-day-through passengers who do not transfer to a different aircraft or whose aircraft divert to Kalgoorlie-Boulder due to inclement weather or for other unforeseen and unplanned operational requirements.

#### Aircraft Landing Fees

All aircraft (including helicopters) landing fees are based on maximum take-off weight per 1000kg or part thereof above 1000kg.
