Airport Paid Parking

Terms and Conditions

By entering an airport parking area, you are deemed to have accepted the following contractual Terms and Conditions of entry:

- When you park and leave your vehicle in this parking area, you do so at your own risk and you remain responsible for your vehicle and any property in or on it.
- You may access or remove your vehicle from this parking area twenty-four (24) hours per day. Before leaving your vehicle in the parking area, you must display a parking ticket or long term parking permit on the dashboard of your vehicle.
- You must park your vehicle within the limits as defined by the lines painted on the surface of the parking area and comply with all signs erected in the parking area.
- You **must not** park your vehicle so as to obstruct or permit the obstruction of the free passage to, within, or the use of, and exit from this parking area.
- We, our agents or our representatives may move or tow away your vehicle for operational, safety or security reasons. We will not be liable for any damage to your vehicle, person or property by such removal. You will immediately pay to us any costs we incur in connection with such removal.
- Except to the extent required by law, we will not be liable for:
 - a) The safe custody of any vehicle in this parking area; or
 - b) The delivery of your vehicle to any person, whether that person has authority to take it or not; or
 - c) Any theft, loss or damage whatsoever to any vehicle, its accessories or contents; or
 - d) Any damage to your property, injury to you, or your death while you, your vehicle or your person is in this or while you are entering or leaving this parking area.
- You must ensure that your parked vehicle is securely locked, valuables hidden from view, windows closed and the ignition key removed.

- You must not litter the parking area, or allow your vehicle to spill or leak oil or other substances in it.
- Be aware that locations within the airport are under camera surveillance. The CCTV cameras installed in and around the parking area are part of our general security and safety measures. They **are not** for the purpose of monitoring vehicles.
- If any part of the Conditions of Use are illegal or unenforceable, that part is to be disregarded and its removal will not affect the remainder of the conditions.
- Tariffs are quoted as GST-inclusive prices.
- The first 24 hours of parking is free and \$10 per day thereafter or part thereof.
- You are still required to have a ticket if you are parking for less than 24 hours.

The pay and display parking machines will issue a ticket which must be displayed on the dashboard of the vehicle.

- Failure to display a valid or current ticket will result in an infringement in accordance with Section 6 of the *City of Kalgoorlie-Boulder Parking and Parking Facilities Local Law 2009*.
- In these Conditions of Use, references to:
 - a) “We”, “us” and “our” mean the City of Kalgoorlie-Boulder ABN 63 711 737 609;
 - b) “You” means the person using or intending to use this parking area;
 - c) “Your vehicle” includes a vehicle driven, or intended to be driven, by you into the parking area.
